Bonus payment offered for a 2016 breeding resulting in a
USTA registered foal in 2017

Owners of mares bred in 2016 to a registered California Standardbred Stallion will be eligible for a bonus payment upon presentation of the USTA registration papers for the live offspring in 2017.

Broodmares must be registered at the Sires Stakes Office
\$25 registration fee due on or before March 1, 2017
CSSSC accepts checks and cash only

USTA Registration of foal is required by December 31,
2017 to receive the Breeders Incentive Bonus

Incentive payments will be issued 90 days after receipt of a copy of USTA registration that confirms the production of a live Cal-sired offspring between registered mating of sire and broodmare.

This program was advertised last year as a \$1,500 award. However, the funding source for this bonus was incorrectly paid to CSSSC and had to be repaid. As such, regretfully, the bonus amount will be reduced to \$750 per foal.
